




# Board Chair Letter

Year two is complete of West Central Minnesota Creating Entrepreneurial Opportunities (West Central MN CEO). While our inaugural year is complete, year two has brought about enough new opportunities to feel like another inaugural year. To bring established knowledge, structure and maintenance of the West Central MN CEO program, the Board of Directors sought partnership with the Midland Institute for Entrepreneurship. The Midland Institute for Entrepreneurship is a not-for-profit organization focused on promoting entrepreneurship among high school students throughout the nation, using high



quality education programs, fostering local community engagement, and partnering with local chapters. Their mission is in alignment with the goals of our program. In August 2021, West Central Minnesota CEO Program became a chapter of Midland Institute. We are grateful for the additional Launch Your Future Today (LYFT) Career Pathways grant through the Southwest West Central Service Cooperative (SWWC) and the Foundation for Innovation in Education grant through Southwest Initiative Foundation to use towards our Midland Institute chapter fee.

In June 2021 West Central MN CEO welcomed a new facilitator - Ryan Luft from the KMS School District. And in late June, our CEO program had the opportunity to add another school district into our collaboration. Central Minnesota Christian School (CMCS) joined Renville County West (RCW), Maynard-Clara City-Raymond (MACCRAY), and Kerkhoven-Murdock-Sunburg (KMS) in its ability to offer this unique class to its students. Both Ryan and CMCS jumped right in to recruiting students for the 2021-2022 school year.

At the beginning of the school year, nine students from three of the four school districts, began their journey as members of the CEO class. Unfortunately, the school year is ending with only three CEO students. We extend our congratulations to these students for staying dedicated to overcoming the fear, adversity, and struggles of creating a business through the opportunity of the CEO class. The individual growth of each student will serve them well in the future.

The CEO class is one of the best investments we can make to offer area students an exceptional opportunity to practice and implement 21st-century learning skills and create their own personal business, before they graduate from high school! Thank you for your partnership by hosting a class, being a guest speaker, mentoring a student, and financially supporting the class. #### **MORE ABOUT CEO**



Creating Entrepreneurial Opportunities is a course designed to utilize partnerships that provide an overview of business development and processes. Our local business community partners with area schools to create project-based experience for providing funding, expertise, meeting space, business tours, and one-on-one mentoring. Business concepts learned through the experiential CEO class are critical; the 21st century skills of problem-solving, teamwork, self-motivation, responsibility, higher-order thinking, communication, and inquiry are at the heart of a student's development throughout the course.

#### **CEO Students will:**

- Attend class every day dressed in appropriate professional attire
- Write weekly journals
- Interact each week with local business and community leaders
- Schedule, plan, and work together at various local events
- Communicate and interact with their business mentor
- Formulate, research, write, and present two business plans
- Actively participate in a class business
- Start their own small business and present it to the community at the CEO trade show

#### 2022-2023 Class:

- When? Class is Tuesday-Friday 7:30 a.m. 8:30 a.m.
- Where? At host businesses in the school districts of CMCS, KMS, MACCRAY, and RCW.
- Transportation? Students are responsible for their own transportation. Designated funds are available for students that need assistance for gas.
- **Virtual class?** At times. However, a program essential is that the CEO students are never in a classroom, but always in one of the different community businesses that are the lifeblood of our communities. This is the experiential, hands-on environment that is foundation to CEO.

#### At the end of CEO, students are expected to be able to:

- Create and present an effective business plan
- Demonstrate effective communication and collaboration skills
- Demonstrate their understanding of appropriate professional attire
- Compare and contrast a wide variety of businesses
- Interact with business owners, community leaders, and class guests
- Execute the creation of a small business

### What makes a CEO student?

Great CEO students are trustworthy, hardworking, and motivated. If students have those characteristics, they have everything necessary to have a successful and transformational experience in CEO. CEO isn't like most school activities. The application process doesn't take into account things like grade point average and extra-curricular activities. The best candidates may include: the student who is very intelligent but is not interested in school, the student that is a bit disruptive because school just isn't their thing, the straight A student who is good at 'school', or the student who is good at learning by doing and appreciates the opportunity to discover, explore, and build.

CEO classes benefit from a wide variety of students. Seeking involvement from people different from oneself is a cornerstone of CEO, and students will quickly appreciate the diversity.
